2a	<p>EAP signed a mortgage for the Zoar Wetland Arboretum in 1998. By 2002, the monthly payments had become a burden and could not be paid with regular donations, and no private or public funding was available from any source to pay off the balance. EAP was in danger of losing the wetland property. EAP had received a gift of vacant land in 2001 to preserve as green space. Early in 2006 EAP started negotiating with an unrelated person to buy the vacant land. In October the mortgage holder had agreed to defer our monthly payments in anticipation of a single payoff when the land sold. However, when the buyer backed out in Dec 2006 EAP was forced to seek a new buyer on short notice to prevent the foreclosure of the wetland property. That buyer is a member of EAP who had knowledge of our financial situation and offered to buy the land on short notice. The EAP Board of Directors reviewed the Conflict of Interest Policy and determined that the transaction would be allowed with full disclosure of the relationship between the buyer and EAP. The January 26, 2007 meeting minutes authorized the transaction by resolution 07-01. The land sold and the mortgage was paid off in March 2007.</p>
